Hence the school is directed to shift the Library and Computer Lab to room size prescribed for affiliation. 6. The school is required to construct washrooms for male and female staff. 7. The school is required to renew all the mandatory certificates from time to time. 8. The school is directed not to remove the essential documents uploaded on mandatory public disclosure of the school website and videography link in future.

School is required to appoint special educator & wellness teacher as per affiliation bye laws.
